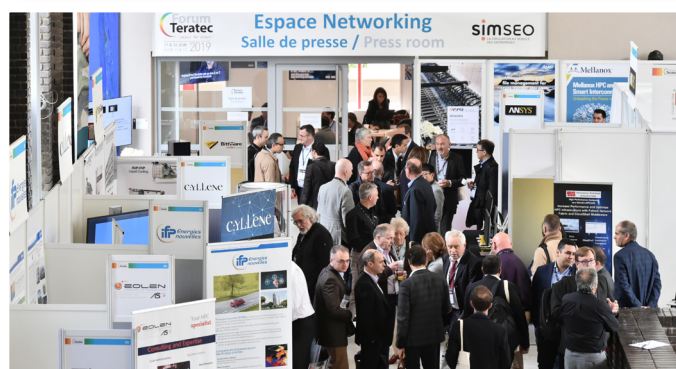

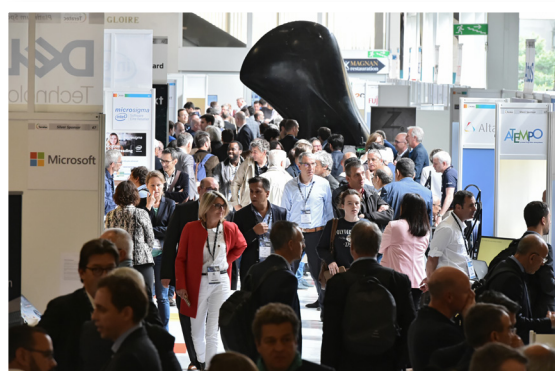
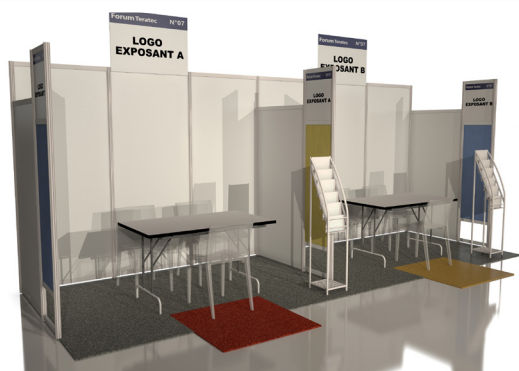

The Teratec Forum is organised by Teratec in accordance with the provisions set out in the General Convention on Occupancy of the Ecole Polytechnique, with which Teratec and the Exhibitor must comply.

For the proper administration of these regulations, Teratec maintains at the disposal of the Exhibitor, at all times, the text of the above mentioned Convention as well as the text of the exhibitor's technical file and the schedule of security conditions established by Ecole Polytechnique.

Teratec and the Exhibitor must abide by the rules enacted, in this matter, by the conventions on occupancy pertaining to Ecole Polytechnique.

Insurance & waiver recourse

In addition to insurance covering exhibit objects and more generally, all the moveable objects, the Exhibitor must be insured, at its own expense, for all risks to himself or his staff as well as to a third party.

Teratec and the Ecole Polytechnique are hereby discharged from all responsibility in this regard, particularly in the case of loss, theft or damage.

The Exhibitor's insurance policy must include an explicit clause relinquishing any and all claims against Teratec and Ecole Polytechnique.

Registration of booking

Stalls are allocated in priority to companies that have returned their booking contract and payment made within deadlines.

Teratec reserves the right to modify booth location if necessary, according to the evolution of the Teratec Forum event and that of the exhibitors' competitive environment.

A stand may not be transferred or sublet without the written consent of Teratec.

The overall amount payable for the reservation becomes due when the contract is signed; the payments must be made according to the agreed schedule.

Disclaimer

In the event of withdrawal, cancellation of the contract or a request for a reduction in surface rented, whatever the date and whatever the reason, the company signing the present contract remains liable for the entire amount, taxes included, of its reservation and for any invoices concerning it, even if the space is subsequently rented to others.

Payment

Should a single one of the payments not be made, the principal amount of the balance of the price and the accrued interest will be right immediately become payable fifteen days after the dispatch of a formal demand which has had no effect, indicating the intention of the organizer to apply the present clause without further legal formalities.

Whatever the case, failure to pay the total amount due for the reservation 15 days before the trade fair will cause the cancellation of the right to make use of the stand without cancellation of the payment obligations.

Payment for the services and additional expenses must be made on receipt of the invoice sent by Teratec or service provider. Every Exhibitor in situation of delay in payment becomes by rights debtor towards the organizer, besides already statutory late charges, of a fixed compensation for 40 euros collection charges (article L.441-6 of the commercial law).

Booth

The Exhibitor agrees to occupy his stand for the duration of the Teratec Forum. No refunds will be given if the Exhibitor's materials do not arrive on time. Teratec will freely dispose of any stand whose holder will not have presented himself before two hours before the opening of the Teratec Forum, without relieving the Exhibitor of his payment obligations.

No-one will be admitted to the event without presentation of a pass issued or accepted by Teratec. The latter reserve the right to expel any person whose behaviour justifies, in their opinion, such a measure.

Orderliness

The Exhibitor agrees to control the noise level and to respect habitual rules of etiquette. The supervision and discipline of the exhibition are the responsibility of Teratec.

Teratec reserve the right to prohibit all or part of materials, signs or products not meeting exhibition standards.

No notice, sign, or other object may be placed outside the assigned stand. The present conditions constitute a binding agreement.

Shootings

Participation in the Forum implies express acceptance by the exhibitors, their staff, contractors and subcontractors that pictures could be taken of their image during the Forum with potential publishing containing their surname and first name on any communication medium related to the Forum.

Cancellation & Report

In case of force majeure, the dates and venue of the Teratec Forum may be subject to modification. In the event that the Teratec Forum is cancelled, all funds available after payment of invoices already accepted will be refunded to exhibitors in proportion to their participation, without any possibility of appeal against Teratec. Teratec reserves the right to notify the days and to change the hours of exhibition.

The present conditions have value of contract.

Disputes

In the case of dispute on the administration or interpretation of the present contract, The Tribunal de Commerce de Paris will have sole jurisdiction.
